

Instillation Certificates

Competent Person Self Certification Schemes were introduced by the Government to allow work installers to self-certify

that their work complies with Building Regulations standards (installers are registered with 'Scheme Providers' responsible for monitoring the standards of their members).

The following works carried out at properties require either an Installation Certificate or Building Regulations Approval;

- Installation of double-glazed windows or doors since 1 April 2002
- Electrical Works (including the installation of new circuits or major alteration to circuits) since 1
 January 2005
- Installation of gas appliances (including gas and oil-fired boilers) since 1 January 2005;
- Installation of Biomass and Solid Fuelled appliances;
- Installation of Solar Panels.

Warning! To avoid delay in your sale, please consider the following;

- 1. Find Search for Installation Certificates that should have been given to you with respect to any triggering works.
- 2. Get Duplicate Contact either the Installer or the Scheme Provider for a 'duplicate certificate' (this may cost you in or around $\mathfrak{L}6$ to $\mathfrak{L}25$ per certificate). A list of the Scheme Providers with contact telephone numbers is listed below.
- 3. Offer Indemnity Insurance If you still cannot trace any evidence that an Installation Certificate has ever been issued, then consider offering the Buyer an Indemnity Insurance policy to cover against the risk of the Council's Building Control department taking enforcement action for non-compliance. The cost of the policy is typically a one off cost of $\mathfrak{L}40$ $\mathfrak{L}350$ and covers multiple installations. It does not cover the cost of defective works. The Buyer should consider obtaining their own expert assessment in this regard (eg survey or recent service report of the boiler by a gas safe engineer).
